## All students requesting transportation must register for a pass each year

Registration form and full payment of \$415.00 must be received by May14, 2024 <u>after</u> May 14, 2024 the payment increases to \$465.00 per student.

Registrations and payment received after May 14, 2024 will be processed provided there is available space on the bus and payment has been received in full.

There is an \$840.00 family cap for families with 3 or more students if received by May 14<sup>,</sup> 2024 <u>after</u> May 14, 2024 the family cap will increase to \$940.00 per family.

Bus routes and stops are assigned only on the data received by the deadline date of May 14, 2024

## Note: Buses often reach capacity prior to deadline, please register early

A student is **eligible** for free transportation (town paid) if their home is more than 2.0 miles from the assigned school and are in grades K-6. All other students may purchase a pass for a fee of \$415.00 by May 14, 2024 subject to availability, \$465.00 after May 14, 2024.

## All students in grades 7 and 12 are required to pay a fee if they wish to have transportation.
